Chapter 1 Typical Application

The typical application of the device is shown as below.




Figure 1-1 Typical Application

Wire the door station to the indoor station with 2-wire cables. You can activate door station by indoor station. Set the open duration and other parameters by indoor station.

Chapter 2 Local Operation

2.1 Live View

On the live view page, you can view the live video of added door station and network camera.

Steps



- Make sure the network camera or door station is well-connected.
- Make sure the indoor extension and the indoor station are well-connected.
- 1. Tap Live View to enter the live view page.




Figure 2-1 Live View

2. Tap to enter the live view page of door station.



- On the Call from Door Station page, there are 2 unlock buttons: Unlock 1, and Unlock 2. When you tap **Unlock 1**, the building gate will open by default. When you tap **Unlock 2**, the door station connected door will open.
- On the Call from Door Station page, there are 1 capture button. You can tap the button to capture the picture via door station.
- 3. Tap a to enter the live view page of network cameras.

2.2 Information Management

You can view public notice, visitor message, and capture log on information management page. Tap **Message** to enter the information management page.

Delete a Log: Hold the item, you can delete it. **Clear Logs**: Hold the item, you can clear all logs.
