Installation*

Place mounting channel in desired location. Drill 1/8" holes through channel into mounting surface every 24". Attach channel to mounting surface. Slide SensingEdge into mounting channel channel. If mounting in vertical position, use a screw at the bottom of the channel as a mechanical stop to prevent SensingEdge from slipping out of position.

Note: For safe operation, use maximum 24 volt AC or DC power.



Care of the ME120 & MGO20. . .

Minimal care is required for the ME120 and the MGO20 since they are manufactured with only the most durable materials and the highest quality control standards. However, SensingEdges™ should be examined regularly for cuts or punctures which could damage internal components. Check wiring to be sure connections are secure. Conduct performance tests regularly to assure proper operation. When properly maintained, both the MGR20 and the MGS20 offer years of trouble free operation.

Warranty

We will replace within one year of shipment from our factory, any SensingEdge™ subject to normal use which is found to have defective materials or workmanship, as determined solely by our factory representative. Replacements will be shipped to you freight collect. This warranty is void where evidence of misuse or abuse is present.
