






1. Vertical mounting




2. Horizontal mounting




3. Adjust tap selector (if applicable)



4. Use Cable gland (outdoors) **or** rubber feed through (indoors) on terminal cover for speaker wire.




5. Connect speaker wire to binding post (Red: +, Black: -)




6. Tightly insert terminal cover into the cabinet groove


More bass output
